- ✓ **BUSINESS HOURS** ARE WEEKDAYS, MONDAY THROUGH FRIDAY, 8:00 AM TO 5:00 PM., EXCEPTING CA STATE HOLIDAYS
- ✓ **AFTER HOURS CALL 292-8300 (EXT. 2)** FOR SERVICE OR VEHICLE RELEASE. A DRIVER WILL BE DISPATCHED TO ARRIVE WITHIN 20 MINUTES FOR SERVICES OR RELEASES. DRIVERS WILL NOT WAIT MORE THAN 20 MINUTES AT THE SHOP FOR RELEASE REQUESTS, NOR ARE THEY REQUIRED TO RETURN ONCE THEY HAVE WAITED.
- ✓ **COMPLAINTS** MAY BE DIRECTED TO BURT DEAN, CFO, OR THE PERMITS UNIT, CITY OF SAN JOSE, 408-277-5429
- ✓ **PERSONAL PROPERTY RELEASE:** PERSONAL PROPERTY RELEASES DURING BUSINESS HOURS FOR UP TO 20 MINUTES WITH STANDBY PERSONNEL AT NO CHARGE. OVERTIME IS AT \$15.00 IN 10 MINUTE INCREMENTS. AFTER HOURS PERSONAL PROPERTY RELEASES ARE CHARGED A GATE FEE TO ACCESS VEHICLE WITH SAME TIME LIMIT.
- ✓ **REQUIREMENTS FOR RELEASE OF PERSONAL PROPERTY OR VEHICLES:**
 - REGISTRATION OR INSURANCE
 - CURRENT, VALID, GOVERNMENT PHOTO I.D. MATCHING THE OWNERS NAME ON VEHICLE DOCUMENTS ABOVE
 - CREDIT CARD, CHECKS, OR CASH PER POSTED POLICY
 - POLICE IMPOUNDS MAY REQUIRE A RELEASE FROM THAT AGENCY (CHECK YOUR PAPERWORK)
- ✓ **DISPUTED TOWS:** "DISPUTED TOW" IS WHEN RTS IS ACCUSED OF PERFORMING ILLEGAL ACTS DURING THE PROCESS OF PERFORMING A TOW OR RELEASE (POLICE ORDERED TOW OR PRIVATE PROPERTY TOW). POLICE REPORT IS RECOMMENDED.
- ✓ **WE ACCEPT CASH, CREDIT CARDS, OR CHECKS, ONLY – CVC 22658**
 - CREDIT CARDS: MASTER CARD, VISA, AMERICAN EXPRESS, DISCOVER OR
 - CHECKS: ACCEPTED ONLY WITH CURRENT GOVERNMENT PHOTO I.D. REQUIRES CURRENT ADDRESS (NO P.O.), AND CURRENT PHONE NUMBER PRE-PRINTED ON CHECK.
